Fred Eaton - Trustee of Municipal Light plant for 6 years.

Ordinance No. 99 - An ordinance re-establishing the vacated alley abutting Lots 14 to 19 on North and Lot 20 on South in Block 3 of town of Laurens.

Ordinance No. 100 - An ordinance repealing Section 12 of Ordinance 68. Street Improvements were major act of 1960

Ordinance No. 101 - An ordinance controlling traffic and prescribing penalties for violation.

1961

New well - Sewer and water on Bissell Street from Sadie to East Str.

Town expanding - Sunrise Addition and Forry-Cooper Division opened

Rubel - M. Warner , Unruh, F. Dubbert, C. B. Stewart, Ziegler and E. B. Pannkuk.

Ordinance No. 105 - An ordinance relating to seasonal limitations and restriction on parking - snow removal.

1962

New police car purchased - new street sweeper purchased.

Curb and gutter work being carried on. Shirley Smith hired as assistant clerk.

Garage built (\$18,000.00) for storage, repair and servicing of town vehicles and equipment. December 3, 1962 - contract with Stan Clark.

October - 261 ballots cast, 162 votes yes - 92 no and 7 blank or defective.

Council - same.

Popcorn stand closed of Elmer T. Johnson for sanitary reasons.

1963

Popcorn stand inspected by Dr. Pitluck - allowed to reopen.  
Town garage completed in July, 1963.

Bussey resigned - Darwin Larson Chief, Willis Godfrey - Assistant

1964

An ordinance repealing Section 2 of revised Ordinance No. 66.  
Third Street widened, bought land for new dump ground cost of \$4,500.00 (10 acres) from Ben Abben of Spencer, Iowa.

August - Change from daylight to central standard time.

October, 1964 - Mayor Rubel resigned (Mayor for 19 years) - Eugene Osier resigned from Council. Lionel Bussey appointed Mayor to fill vacancy.

Bottle gas to be used for coming heating season - November 2, 1964.

1965

Study for natural gas in town.

Ordinance No. 109 - May - An ordinance to establish a town dump.

Miles Warner resigned. Shirley Smith hired as town clerk for \$300.00 per month.

An ordinance: Amendment to Ordinance No. 77.

Special Police appointed for home athletic events - October.

Osier Mayor, Shirley Smith, Clerk.

Councilmen: C. B. Stewart, Darrell Oleson, L. V. Bussey, E. B. Pannkuk and Vince Triggs.

1966

Emergency vehicle bought for fire department from Laurens Implement.

Ordinance No. 110 - An ordinance providing for licensing and regulations of bicycle in town of Laurens.

New water meter - "Read-o-Matics"

1967

Eugene Osier resigned - Darrell Oleson to succeed Osier as Mayor. Gene Osier replaced Oleson on Council

Dump truck bought from Laurens Implement. County Conservation Commission granted 10 years lease for recreational park.

Siddall off Municipal Light and Power - Chairman since the beginning. Curb and gutter still going on. C. I. Hersom awarded contract for street improvements. Bill Edmonds, C. B. Stewart, E. H. Osier, L. V. Bussey, E. B. Pannkuk. Oleson - Mayor. Smith - Clerk.

Ordinance No. 112 - An ordinance creating a planning and zoning commission.

Harley Bradburn, Ron Hersom, Michael Hakes, Leonard Sernett, Mrs. Miles D. Oleson, William Maurer, Mrs. John Hodges.

Tepee Burner purchased. Land purchased east side of East Street from Darold Brown for expansion.

1968

Oleson - Mayor. Shirley Cash - Clerk. Pitluck - Health officer  
C. B. Stewart, Lance Jensen, E. B. Pannkuk, L. V. Bussey, W. L. Edmonds.  
Joe E. Miller hired in March, 1968.

Ordinance No. 113 - An ordinance authorizing fluoridation of public water supply - Street construction being carried on.

Civil Defense Agency for Laurens established.

November, 1968 - Spray for Dutch Elm disease discussed.

1969

All officers the same.

Ordinance No. 114 - An ordinance prohibiting breaking, cutting or opening of surfaced streets with permit and payment of fee.

Ordinance No. 115 - Removal of tree infected with Dutch Elm disease.

Ordinance No. 116 - An ordinance creating the town Planning and Zoning Commission for town of Laurens.
